Sub: Grant of additional attempts to the students of various Diploma Programmes.

**Decision 1.3:** Students of **2013 batch (03 years Diploma Programmes)**, with **04 or less number of courses pending completion of Diploma**, are granted **the Final attempt i.e. Nov 2021 Board Examination**, to complete their Diploma Programmes, failing which they stand exited from the system.

**Decision 1.4)** : Students of **2013 batch (04 years Diploma Programmes)**, are granted **two additional attempts i.e. Nov 2021 and April 2022 Board Examination**, to complete their Diploma Programmes, failing which they stand exited from the system.

**Decision 1.5)** : Students of **2012 batch (04 years Diploma Programmes)**, are granted **a Mercy attempt i.e. Nov 2021 Board Examination**, to complete their Diploma Programmes, failing which they stand exited from the system.

**Decision 1.6)** : Students of **2011 batch (04 years), with 04 or less number of courses pending completion of Diploma**, are granted **the Final attempt i.e. Nov 2021 Board Examination**, to complete their Diploma Programmes, failing which they stand exited from the system.

**Decision 1.7)** : Students of **2014 batch (03½ years Diploma Programme in Food Technology)**, are granted **two additional attempts i.e. Nov 2021 and April 2022 Board Examination**, to complete their Diploma Programmes, failing which they stand exited from the system.
