Sealed Tenders are invited for disposal of unserviceable and condemned vehicles (GA-01-G-3552 Maruti Zen) on "AS IS WHERE IS BASIS" so as to reach the office of the Directorate of Technical Education, Porvorim Goa up to 10.30 am on 18/09/2019

Tenders will be opened in the office of the Director of Technical Education Porvorim Goa on same day at 11.00 am during which period the tenderers or their authorized representatives may remain present. Tender catalogue alongwith terms and conditions can be obtained from the same office on all working days/hrs. on payment of Rs. 100/- (non refundable) per set from 26/08/2019 to 16/09/2019 (up to 4.00 p.m.).

Lots shall be available for inspection from 26/08/2019 to 17/09/2019 (up to 4.00 p.m.) as per details of locations mentioned in the tender catalogue.

- (a) Earnest Money Deposit will be at the rate of 25% of the quoted bid value per lot. The same shall be in the form of D.D./Pay Order/D.C.R. of any scheduled Bank drawn in favour of "Director of Technical Education", Porvorim, Goa, payable at Panaji and to be enclosed by all bidders alongwith their offer.
- (b) The EMD of the successful bidder will be adjusted against the final bid value. The balance 75% of the bid value shall be paid by the bidder within 7 days after getting intimation from the auctioning authority.

The balance payment shall be in the form of D.D./Pay Order/D.C.R. of any scheduled bank drawn in favour of "Director of Technical Education", payable at Panaji. In case of failure to make balance payment in time the amount deposited as per clause (a) above shall stand forfeited to the government.

The successful bidder shall lift the lot within three weeks of receiving the intimation letter from the department and in the event of failure to do the same, then the amount deposited as per clause (a) and (b) above shall stand forfeited to the government.

GST payable on condemned vehicle at the prevailing rates on the amount quoted by the bidder on the bid article shall be collected from the successful bidder at the time of the final payment.

The Department reserves the right to accept or reject any or all the tenders without assigning reasons thereof.
