## **TERMS AND CONDITIONS**

Sealed envelope super scribed "Quotation for purchase and supply of UPS Batteries" containing the tender documents duly signed by the tenderer(s), other necessary documents as mentioned in this tender form should reach either by post or by person at the address given below on or before 23-11-2015 (14:30 Hrs)

- 1. The interested bidders who wish to participate in the tender may download the tender form from the website <u>www.dte.goa.gov.in</u> or obtain the same from the office of the Directorate of Technical Education at Porvorim, Bardez, Goa during office hours. Following payments in the form of demand draft/pay order of any scheduled/nationalized bank payable at Porvorim, Goa:
  - a. Cost of Tender documents amounting to Rs. 100/-(non refundable) in form of (Cash/DD/Pay Order from Scheduled/Nationalized bank) drawn in favour of Director, Directorate of Technical Education, payable at Porvorim.
  - b. Earnest Money , amounting to Rs. 10,000/- must accompany the tender in the sealed cover super scribed ""Quotation for purchase and supply of UPS Batteries" along with the reference number/date of Tender Notice as well as last date receipt & Opening of tenders. The quote must be addressed to the Director of Technical Education and put in tender box kept in Department for this purpose within the closing time & date specified.
- 2. Tenders received after due date and time stated above will not be entertained under any circumstances. DTE will not be responsible for any postal delay or misplacement of Tender documents sent by post.
- 3. Tenders will be opened at DTE on 23-11-2015 (16:00hrs) in the presence of the interested tenderers or their authorized representatives whoever are present.

- 4. Tenderer (s) shall indicate complete specifications and all features of the UPS Batteries.
- 5. Tenderer's sending their tenders by mail/courier/post will do so solely at their risk and the Department will not be responsible for any loss in transit or postal delay.
- 6. Tender documents are not transferable.
- 7. Tenders should enclose inside the sealed cover all the following documents:
  - a. Cash receipt/DD towards cost of tender, DD/P.O/ towards Earnest Money, affixing rubber stamp at the back of EMD showing the name & address of firm/party as required.
  - b. Terms & Conditions of tender duly signed and also quote with declaration in 'Annexure A'.
  - c. Proof of manufacturing/authorized distributorship.
  - d. Proof of battery maintenance base in Goa.
- 8. In case the information submitted by the tenderer is found to be incorrect/false, at any stage, tender of such party will be rejected and not considered any further.
- 9. DTE reserves to itself the right to reject any or all the tenders without assigning any reason thereof and to call for any other details or information from any of the tenderers.
- 10.Director, Directorate of Technical Education, shall have the right to postpone/extend the date(s) of submission of tender /opening of bids.
- 11. The selected tenderer shall supply, install and calibrate the item with the existing UPS and remove the existing Batteries, within 15 days of the date of receipt of purchase order from DTE.
- 12.If the selected tenderer fails to supply, install and calibrate the UPS Batteries within the said period of 15 days, the Director shall be entitled to cancel the purchase order given to the tenderer without giving any notice and without any obligation whatsoever and make alternative arrangements for supply of the material.
- 13.Selected tenderer is liable to pay the required Service Tax/VAT/other taxes as are applicable, as may be decided by Central/State Governments from time to time. DTE shall not have any responsibility in this regard.

- 14.Only manufacturers of Exide, Amaron(Quanta), Panasonic or, Yuasa batteries or their authorized distributors can participate in the tender. The tenderer should submit proof of their manufacturing / authorized distributorship. This is subject to verification, if necessary.
- 15.The price must be quoted as per proforma for price schedule "Annexure A" both in words as well as in figures. It shall be inclusive of all applicable taxes, charges, levies, handling and transportation charges, etc. VAT and entry tax shall be indicated separately. Overwriting of rates should be avoided. Tenderer must initial any cutting / rewriting / overwriting of rates. Nothing over and above the quoted price would be payable to the successful bidder. Price quoted shall be valid for 60 days from the date of opening.
- 16.In case the firm fails to comply the purchase order within the stipulated period and are not willing to perform the contract, his EMD amount shall be forfeited and the item will be procured from the next lowest tenderer.
- 17.The bidder should carry an on-site **comprehensive warranty/guarantee** of the item for a period of at least 36 (thirty six) months. It shall be the duty of the contractual firm to replace/repair any of the non-functional Batteries during the Warranty/Guarantee period. Date of warranty/guarantee shall commence from the date of successful commissioning.
- 18. The installation and calibration of the new batteries with the existing UPS shall be done by qualified technicians having prior experience in dealing with UPS. The selected tenderer shall be fully responsible for any loss,

damage, expenses, if any, that may be caused to DTE due to any defective installation and calibration and such amounts shall be recovered from the contractor.

- 19.It is the responsibility of the bidder to take the 60 UPS batteries (under buy back) from DTE and no expenses will be borne by DTE.
- 20.Non-compliance with any of the conditions given herein may lead to the rejection of tender.
- 21.Successful bidder shall have to provide a performance guarantee of 10% of the amount quoted.
- 22. All disputes are subject to Panaji, Goa , jurisdiction, only.
