Sub: Amendment to Board Rule 13D

Ref: Board Meeting dated 5th June 2014.

Board in its meeting on 5th June 2014, approved an amendment for Board Rule 13D, for revaluation of answerbooks, in respect to procedural clause 13D(ii) as under:

13D(ii) "Revaluation shall be done by a fresh examiner. Higher marks of the two, between Original and Revaluation assessment, shall be considered for the benefit of student while declaring the result. However, if the variation in, Revaluation marks and Original marks, is more than 20% of the maximum marks allotted to the paper, the paper shall be sent to a third examiner for revaluation. The average all three scores (Original,1st Revaluation & 2nd Revaluation) shall be the revaluation marks allotted to the candidates, provided this average is not less than the original".

However, the fees to be charged towards revaluation of answerbooks remains unchanged. This amended Board in Rule 13D shall be implemented with effect from forthcoming November 2014 Board Examination onwards.
